## **Participant Entry**

Where an age restriction applies, participants must be the specified age or above on the day you register for the Challenge. If no age restriction applies, if you are under 18 you confirm that your parent/guardian has agreed to your participation.
- 3. You will need to register for Barnardo's 350,000 Steps Challenge by following the instructions on our event form.
- 4. Barnardo's 350,000 Steps Challenge can be completed in your own time and in your own way. We may provide tips on how to stay safe whilst completing Barnardo's 350,000 Steps Challenge, please read these and ensure to comply with them.

#### **Fitness**

## **Fundraising**

- 6. You will only use lawful means to fundraise and will abide by the Fundraising Regulator's Code of Practice.

- 8. Any monies raised in connection with Barnardo's 350,000 Steps Challenge are held on trust for Barnardo's. All participants have a legal responsibility to ensure that all sponsorship monies/donations raised in connection with the Challenge are paid to Barnardo's by:

- 9. Funds raised in connection with Barnardo's 350,000 Steps Challenge must be paid to Barnardo's within 30 days of you completing the Challenge.

# Use of your information

- 13. Only provide personal information on behalf of additional participants if they have confirmed that they are happy for you to do so as we will use this information for the same purposes outlined in clause 13.
- 14. Personal information may also be used for the purposes of sending communications to you in line with the consent given by you when registering for Barnardo's 350,000 Steps Challenge.
- 15. All personal data held by us will be handled in accordance with applicable privacy laws and Barnardo's Privacy Notice.
